## Description

**Strain Designation:** VRC 24

**Product Description:** An ampoule containing viable cells (yeast cells, spores, or agar cubes with mycelia) suspended in cryoprotectant.

## Propagation

The information recommended in this section is to assist users in obtaining living culture(s) for their studies. The recommendation does not imply that the conditions or procedures provided below are optimum. Experienced researchers may initiate the growth of a culture in their own way.

## Growth Conditions

**Temperature:** 30°C to 37°C

**Atmosphere:** Typical aerobic

## Recommended Procedure

**Frozen ampoules** packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a **25°C to 30°C** water bath, until just thawed (**approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µL (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 4-5 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

**Colony and Cell Morphology:** On PDA medium at 30°C after 21 days, mycelium white to cream becoming olive brown to dark brown, cottony with some tufts of mycelium. Reverse tan to brown becoming dark brown with white margin. Hyphae hyaline, guttulate. Conidiophors biserial, vesicles globose. Conidia greenish brown, globose to subglobose, smooth, contain oil droplets, 2-4.5 X 3-3.75 µm.

Type strain of the species, broad spectral antimicrobial activity.
